# **Yearly Assessments and Garbage Pick-Up**

The invoices for the 2016-2017 Annual Assessment have been sent out. The assessments set at this year's Annual Meeting were set at \$10.00 per lot and \$190.00 per house. Therefore, if you own one house and one lot, your assessment for 2016-2017 is \$200.00.

Any assessments <u>not</u> received by December 31<sup>st</sup> will have a late fee added to the assessment.

Garbage Pick-Up must now be arranged by each individual homeowner. The CLBA Board will only negotiate the CLBA rate. You can contact Advance Disposal before October 1, 2016 to continue your services. The negotiated fee is \$17.00 per month per house for garbage and recycling. You can arrange for year round or just the summer. Call 847-623-3870.

## **CLBA Annual Meeting Update**

The Annual Meeting was held on **Saturday**, **July 9**th, and called to order at 8:48 AM. Thanks to all those that attended *and* to all those that sent proxies prior to the meeting.

Following is a brief synopsis of what was discussed at this year's meeting:

- 1. ASSESSMENTS: As always, assessments were discussed after the approval of the yearly budget. Assessments were set again this year at \$190.00 per home plus the required \$10.00 per lot.
- 2. YEARLY DRAWING: It is with great sadness that the CLBA Board informs you that our neighbor MarcAnthony Beaton, who was the winner of the Annual Association Member's Drawing, unexpectedly passed away on September 18<sup>th</sup> due to complications from diabetes. Our thoughts and sympathies go out to his family and friends.
- 3. BOOKKEEPER/CPA: The Members In Good Standing voted to turn the financial responsibilities of the Association over to an outside Bookkeeper/CPA. The Board already has one bid for these services, and will be obtaining 2 more bids before making a decision. Cathy Phillips agreed to stay on for 90 days as the Business Secretary, and Christine Ryder agreed to perform the duties of Treasurer for 90 days until a Bookkeeper/CPA has been chosen.

#### **General News and Reminders:**

<u>Garbage</u>. All garbage pick-up - whether seasonal or year-round - is now the responsibility of the individual home owner. The CLBA has found Advanced Waste to be the least expensive of the available area providers at \$17.00/month. They can be reached at 847-623-3870.

<u>Parking</u>. Some Association Members and renters use the streets for additional parking. Aside from the fact that this is against the Rules and Regulations of the Association, it hinders emergency vehicles from quickly and safely reaching our neighbors in need. The streets need to be kept clear so emergency vehicles can have clear access. Cars may be tagged and possibly ticketed if found to be in violation.

Association Common Area Property. If anyone is found damaging Association Common Area Property - be it at the beach/park area, the boat launch area, the walkway, or anywhere else - be advised that you will be prosecuted and fined to the fullest extent possible.

<u>E-Mail Addresses Save Money.</u> In an effort to save money/reduce costs, the CLBA Board is asking you to submit an e-mail address to which we could send the CLBA News. Once your e-mail address has been received, you will be awarded a onetime credit of \$5.00 that will be applied to your Annual Assessments.

**Burning.** The CLBA Board has no authority to confront this type of situation. Lake County Nuisance Ordinance, updated in April, 2014, cite that recreational fires must be "3'x3'x3'" and are to be for warmth, human consumption, and/or temporary non-ceremonial services" and does not contain any yard waste, garbage, junk, or debris. Yard waste burning is cited with "it is a public nuisance to conduct open burning" of yard waste in the designated unincorporated area, "subject to the following exceptions"... "when all of the following restrictions are met": 1) burning is DONE between 5:00 pm and 8:00 pm or sunset (whichever is earlier) Monday thru Friday or between 12:00 pm and 8:00 pm or sunset (whichever is earlier) Saturday, Sunday, and legal holidays; 2) burning has been extinguished with no smoke emanating by 8:00 pm or sunset (whichever is earlier); 3) burning occurs on the premises where the yard waste

was generated; and 4) the burning is conducted no closer than 50 feet from a school property line, 50 feet from the centerline of the road, 25 feet from a building, and 25 feet from the side property line.

Please be courteous of your neighbors if you have a fire of any type, as we have many individuals in the CLBA with asthma and allergies that are affected by the smoke particles. Never leave any fire unattended at any time. The authorities will be called for any fire found in violation. Thank you for your cooperation.
