WATERCRAFT LAUNCH REPORT from John:

We talked about the Fox Waterway dredging paperwork and Rip Rap at launch for holding back the erosion, but made no decisions as John is out of town and we need his input. Both items will be tabled until next month.

Jody has priced the riprap to help stop erosion and everything is over \$1000.

- * <u>Park</u> We discussed attaining a quote from B & E Services to grade the hill and seed, remove a large stump and take down a tree. This discussion and decision will be tabled until Spring 2022.
- * <u>Street Lights</u> The street lights were checked and the lights were out at both the launch and the beach. Both need to be replaced.
- * <u>Accountant</u> Christine informed us that the accountant's daughter has COVID. Because of this, she is a little behind. She said she will close out our month and get us our outstanding invoices as soon as possible so we can send them out.
